Description:

This two-part program will discuss social media as an advertising tool for lawyers, focusing not only on the types of possible uses of social media, but also on the ethical obligations for a

lawyer in discussing achievements or cases on their social media. The other part of the program will include a discussion of the duties of lawyers in social media aspects such as cross-examining witnesses, and presenting social media evidence before the court.

The professionalism content will include:

- Duties of confidentiality when looking at creating a website or a social media presence – the duty to the client and maintaining confidentiality (Applicable Rule 3.3-1)
- The ethical obligations of lawyers in doing social media searches on witnesses, and the practical considerations involved (Applicable Rules: 5.2 and 5.3)
- Discussion of section 4.2 of the Rules of Professional Conduct relating to marketing of professional services, and section 4.3 relating to the advertising nature of the practice when talking about one's social media presence and websites (Applicable Rules 4.2 and 4.3)
- The duty of advocacy in pursuit of all possible defences and issues: including using social media to vigorously bring forward all possible defences and issues (Applicable Rule: 5.1-1)


