FAMILY RESPONSIBILITY OFFICE - PANEL LAWYERS

Join the Family Responsibility Office's Legal Panel

Ontario's Family Responsibility Office (FRO) receives all support orders made in Ontario and enforces the amounts owed under the support orders. FRO has legal authority to take enforcement action against those who do not meet their support obligations.

The Family Responsibility Office (FRO) maintains a panel of private sector counsel to represent the Director of the Family Responsibility Office in enforcement proceedings across the province.

The Ministry of the Attorney General is seeking applications from qualified lawyers to join the provincewide panel of lawyers providing legal services on behalf of the Director of FRO. Each year, FRO counsel and the panel of

lawyers appear in courts across the province under the Family Responsibility and Support Arrears Enforcement Act, 1996.

Successful candidates must demonstrate skills and experience in family law and litigation and participate in mandatory educational seminars.

4. INFORMATION UPDATES: PRACTICE

Client Contingency Planning

What: All sole practitioners will be required to confirm that they have created a

client contingency plan and have an administrator. Licensees practising in firms (partners and associates) will be required to confirm that their

firm has a plan.

Who: Lawyer and paralegal licensees in private practice, including sole

practitioners, partners and associates.

When: This requirement comes into force January 1, 2025, and will be first

reported on the 2025 Annual Report Filing, which must be filed by March

31, 2026.

Why: When a licensee is suddenly unable to provide legal services, clients

with active matters may have their legal interests jeopardized. Having a

client contingency plan serves the public interest and may also reduce stress on licensees and family members who may otherwise be burdened with having to wind-up a professional business at a very difficult time.

Foundations of Sole Practice

What: New sole practitioners will be required to complete the Foundations of

Sole Practice course.

Who: Lawyer and paralegal licensees who declare as sole practitioners for the

first time from January 1, 2025, onwards.

When: Licensees who declare as sole practitioners at any point in 2025 will

have until December 31, 2026, to complete the course. Effective January 1, 2026, licensees who declare as sole practitioners on or before May 31 will have until the end of that calendar year to complete the course. Licensees who declare as sole practitioners on June 1, 2026 or later will have until December 31 of the following calendar year to

complete the course.

Why: The Law Society has a statutory duty to ensure baseline competence of

lawyers and paralegals in the public interest. Ensuring entry level competence for sole practitioners is critical to complying with this duty. Reducing the risk of practice management and communication errors for

licensees protects the public interest.
